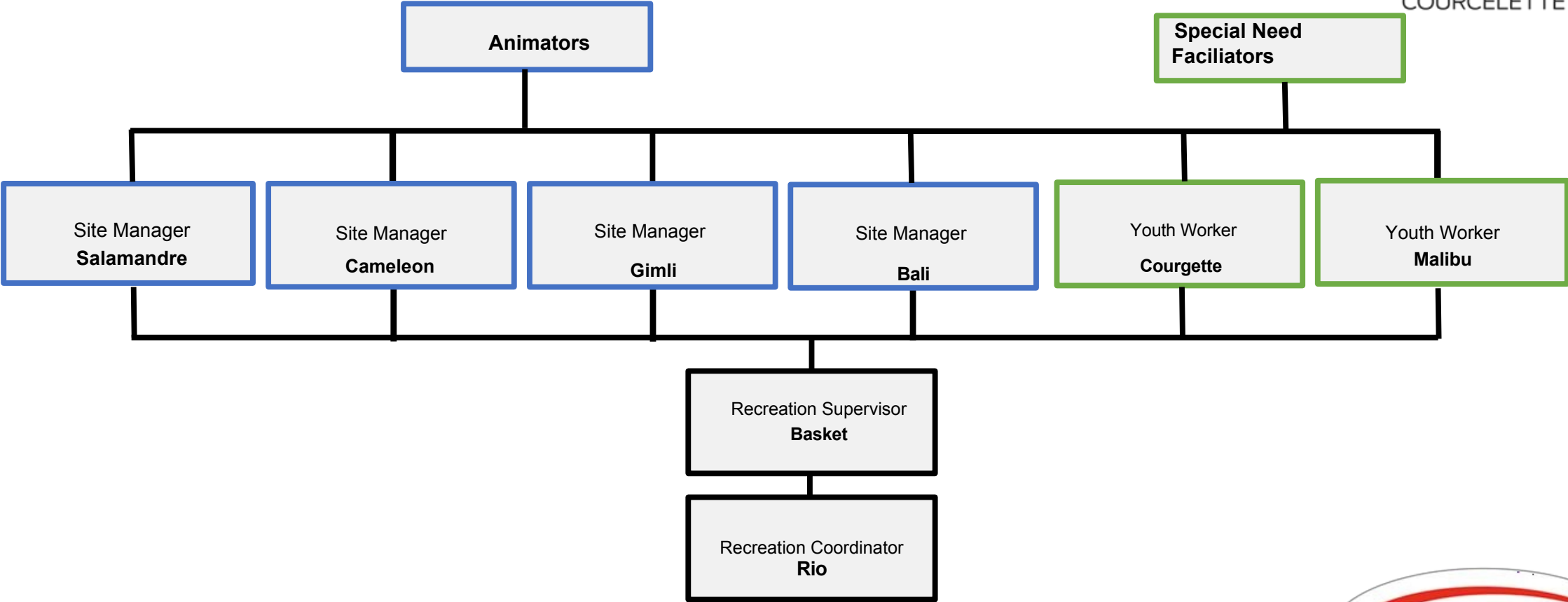

ARRIVAL AND DEPARTURE PROCEDURE

Arrival

- Your child may arrive between 6:45 a.m. and 8:30 a.m.;
 - You must check in at the reception desk inside the building
 - The gathering is a highlight you won't want to miss!
(Themed activities, comedy, performances, etc.)
 - Group activities begin around 9:00 a.m.

Departure

- Departures will take place between 3:30 p.m. and 5:00 p.m.;
- Only authorized individuals may pick up the child.
 - *They must present a **valid form of identification***
 - We may ask you to drop off or pick up your child at a location other than the Valcartier Community Center if we are not operating during regular hours.
 - **After 5:00 PM, fees will apply**

Illness



Fever

- Keep the child home if they have a fever.
- The child may return **24 hours after symptoms have completely disappeared, without medication (Tylenol, Advil, etc.).**

Gastroenteritis

- Symptoms: vomiting, diarrhea, cramps, sometimes fever.
- Keep the child home **for 24 hours after symptoms have resolved, without medication.**

Head lice

- The child must stay home while undergoing **lice treatment.**
- Return to camp is possible **after treatment, provided no lice are visible.**
- Apply a second treatment **7 to 10 days later.**
- Wash clothes in hot water and remind your child not to share hats, helmets, or brushes.



SAFETY PROTOCOLS

- In the event of an evacuation
- In case of a runaway
- In the event of an active shooter
- In case of a minor injury

*Safety protocols have been developed and are known to all staff members.

SWIM TEST



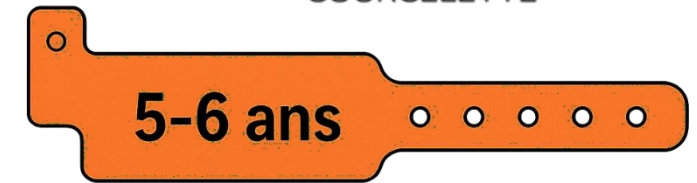
- Groups ages 5–6
 - Swimming mainly in the wading pool
 - Life jackets required in the main pool
 - Life jackets required during “WOW Aquatique” activities

- Groups 7 years and older
 - Life jackets required if
 - Requested at registration;
 - Your child requests it
 - The swim test is not passed or has not been taken.



SWIM TEST

- Three skills:
 - Safe entry into the deep end of the pool
 - Sliding into the water;
 - Jumping into the water;
 - Swim in place for 1 minute
 - Keep airways above water at all times;
 - Swim 25 meters
 - Horizontal position.
- Result:
 - **Pass:** if the child completes all 3 exercises without interruption;
 - **Wearing a PFD:** if the child participates in the exercises but needs a break or does not meet the criteria.



SWIM TEST

- 3. Exemptions
 - Swimmer Level 4 (or higher) passed since Fall 2025*, exempt from the swim test (with proof of the logbook);
 - Send proof via email to aquatiquevalcartier@cfmws.com
 - The parent requires the child to wear a life jacket;
 - The child requests to wear a life jacket.

*No previous results will be accepted.

WHAT TO PACK IN YOUR BACKPACK



Food

- 2 healthy snacks (e.g., fruit, vegetables, cheese)
- Cold meal or thermos + utensils if needed (no microwave access)
- Water bottle (reusable bottle)
- Ice pack
- Paper towels as needed

Other

- Sunscreen
- Insect repellent

Clothing

- Swimsuit
- Towel
- Clothing appropriate for the weather and a change of clothes in case of rain
- Spare underwear (ages 5–6)
- Hat
- **Closed-toe** shoes or sandals
- Sunglasses allowed
- Appropriate clothing

LOST AND FOUND



- A table will be available at the entrance to the community center.
- At the end of each week, any unclaimed items will be donated to a community organization (or discarded).

CODE OF CONDUCT



- The children have the opportunity to live in an environment where Teamwork, respect, and fun will be the focus.
- The following actions or behaviors will not be tolerated:
 - Aggression, physical, verbal, or psychological violence;
 - Running away;
 - Bullying, physical or verbal threats;
 - Theft or extortion;
 - Disrespect, insults, vulgar or hurtful language;
 - Behavioral problems;
 - Engaging in sexual acts.
 - Any action that violates health and safety measures (e.g., spitting on another child).

** This also applies to parent users*



WARNING SYSTEM FOR CHILDREN – RESPECT Program

1st offense: **Verbal warning** to the child, parent's signature, and acknowledgment of the next steps in the warning system;

2nd offense: **Written warning** to the child, parent's signature, and acknowledgment of the next steps in the warning system;

3rd offense: **One-day suspension from camp** with no refund; written warning to the child requiring a parent's signature. An intervention plan may be implemented.

4th violation: **One-week suspension from camp** with no refund, written warning to the child with parent's signature. An intervention plan may be implemented

5th violation: **Permanent expulsion from day camp** with no refund, written warning to the child with parent's signature

WARNING SYSTEM FOR CHILDREN – RESPECT Program



The steps are not automatically applied in order based on the severity of the child's actions. For example, it is possible to move from Warning 1 to Warning 4 depending on the behavior.
