1. CERs for SUPs (2) and Surfski (1) have been approved. For the Surfski, I have asked Kevin at Surfside to provide an invoice directly to Greg for an EFT. For the SUPs I need someone to call in with a credit card *[Marc]* to Vikki at Comox Valley Kayaks. (I will have already picked them up)
2. Next up will be disposing of the 2 inflatable SUPs that no longer hold air. I will also be disposing of the 2 kayaks that received no bids last year.
3. Repairs to solid SUPS and kayaks have been completed. Fleet is ready for the season.
4. Training sessions will begin in Feb dates TBD (CommsO mention in the next newsletter for people to contact me)

1. Pacific Green: repairs are progressing. Will be in Campbell River for bottom work 17-28 Feb. (tracking well)

1. 2nd round of interviews done - so far we have about 14 applicants including ordinary and associate (sign up will open to ordinary and associates 1 Feb, just regular members are currently paying for the course.)
2. ROC-M in house session slated for 25/26 Jan at the clubhouse - expecting the last batch of students once that is complete. 3rd round of interviews to follow.
3. we currently have 5 confirmed on water instructors and 2/3 spares. We lost one due to upcoming surgery so are looking for 1-2 more on water instructors if they can be found. Callout to all keelboat owners coming.
4. Ian is confirmed for testing.
5. Planning 18 students for now with possibility of 21 but dependent on instructors and boats.
6. I am off to Japan end-Jan for a course for 3 weeks and then I am likely being deployed/posted late July for just over a year. I will run this years course but likely will not be able to do the 2026 course. I am hoping to be back after that for the 2027 season this will need to hand over the course for 2026 to someone. If we can find someone to shadow that would be great. Possibly Ryan Verma?
